## **2022-23 Official Rules**

---

### **I. Contest Entry**

- A. Entry forms can be found through direct mailings, newsletters or at the website [www.sunflowerdiv.com](http://www.sunflowerdiv.com). Sunflower Diversified Services Foundation, Inc. is the sponsor of the drawing. If submitting an entry by mail, send entry to:

Entries may also be submitted through our website at [www.sunflowerdiv.com](http://www.sunflowerdiv.com), except as noted below.

- B. There is no limit to the number of tickets that a person may submit, however only 5,000 tickets will be sold.
- C. Entries for the Chevy Trailblazer Activ raffle must be received by the Sunflower Diversified Services Foundation, Inc. prior to 6:30 p.m. central time on March 30, 2023. Postmarks on mailing do not constitute proof of delivery.
- D. The drawing will be at 6:45 p.m. central time on March 30, 2023. Sponsor and Sunflower Diversified Services, Inc. (SDS) are not responsible for any acts of God or natural disaster that might cause cancellation or delay of the drawing and/or awarding of the prize.
- E. A donation of \$25 is required to enter the drawing or five tickets may be purchased for \$100. Sunflower Diversified Services Foundation, Inc. is registered with the State of Kansas Department of Revenue Charitable Gaming Office with the raffle license number of RAF00200. Any entry that is less than \$25 and that is not marked as just a donation will be sent back with a letter explaining that we no longer accept opt out entries for this drawing.

### **II. Prize Available**

- A. The prize will be a brand new fully loaded 2022 Chevy Trailblazer Activ valued at \$29,520. Sunflower Diversified Services Foundation, Inc. reserves the right to substitute alternate prizes of comparable or greater value in the event any of the above are unavailable.
- B. The Prize is awarded "as is".

### III. To Claim Prize

- A. The prize will be awarded in Great Bend, Kansas, and the winner is responsible for transportation to Great Bend, Kansas, to pick up the prize.
- B. Income taxes, property and sales taxes, registration fees, titles, licenses, insurance and other incidentals are the sole responsibility of winner. The Internal Revenue Service requires winner pay 25% of fair market value minus the amount of the wager (ex. \$29,520 (fair market value) - \$25 (ticket cost) = \$29,495 x 25% = \$7,373.75(tax due)). Taxes submitted by winner to the Sunflower Diversified Services Foundation, Inc. are remitted to the IRS via Form W-2G. Tax is due prior to winner taking possession of vehicle.
- C. Winner agrees that the Sunflower Diversified Services Foundation, Inc. and Sunflower Diversified Services, Inc. may use winner's name, address, likeness, and/or prize information, for promotional purposes in any medium without further compensation.

### IV. Eligibility

- A. Only natural persons eighteen (18) years of age or older may participate.
- B. The drawing is closed to employees' of Sunflower Diversified Services, Inc.
